NEW PLAY DEVELOPMENT: THE 2020/21 SEASON WAS ATYPICAL FOR MILWAUKEE REP AND THE NEW PLAY DEVELOPMENT DEPARTMENT AS OUR ABILITY TO PRODUCE AND DEVELOP NEW WORK WAS GREATLY HINDERED BY THE COVID-19 PANDEMIC. WE WERE, HOWEVER, ABLE TO HOST TWO ZOOM WORKSHOPS OF A NEW MUSICAL ONE MAN TITANIC. ADDITIONALLY, WE WERE ABLE TO MOVE FORWARD ON SEVERAL COMMISSIONS AND WORKS-IN-PROGRESS WITH LLOYD SUH, ERIC SIMONSON AND GORDON GANO, IDRIS GOODWIN, JON RUA, AND DAEL ORLANDERSMITH. WE ALSO
